WVVMA All-State Chorus Accompanist Audition Information

Information:

- A call for auditions will be made no later than September 15th.
- Auditions are open to all WV high school students.
- Auditioning students must have verified accompanying experience!
- A member of the WVVMA must sponsor the student who is auditioning.
- Auditions will take place before December.
- If no more than 2 students register to audition, they will audition during their region's choir auditions.
- Auditions will take place at a centralized location for those auditioning and judging.
- Audition judges will consist of the WVVMA All-State Chairperson and two guest piano expert judges (who are chosen by the All-State Chairperson).
- Auditioning students will prepare all accompaniments.
- Auditioning students must be able to play voice parts (two or more simultaneously) for all songs accompanied or a cappella.
- A passing student must have an average of 68 out of 75 to be chosen.
- The highest passing score is chosen.
- If the committee approves, up to two accompanists can be chosen. They both must have scores above 68 and must be the two highest scores.
- If students cannot pass the audition, a professional accompanist will be hired.

Audition Process:

- Introductions.
- Assigned repertoire accompaniments (selections from the rep will be sent the morning of auditions).
- Playing vocal parts (selections of two voice parts to be played simultaneously will be sent the morning of auditions).
- Scales and arpeggios (1 octave, ascending and descending chromatically).
- Playing warm-ups (judges will give a warm-up and see if the student can transfer it to the keyboard).
- Student will be expected to follow a conductor at the audition. (The All State Chair will direct the audition as in a typical rehearsal/performance setting.)
